STATE LAND USE PLANNING ADVISORY COUNCIL

In 1973, the Nevada State Legislature created the State Land Use Planning Advisory Council (SLUPAC) consisting of seventeen members. The members are elected officials or representatives of local political subdivisions appointed by the governor, one from each county. Duties of the council include:

1. Advising the Administrator of the State Land Use Planning Agency on the development and distribution of information to cities and counties on land use planning.
2. Developing recommendations for planning in areas of critical environmental concern.
3. Resolving inconsistencies between land use plans of local government entities.

SLUPAC meets periodically at the call of the Chair or request of the Administrator of the State Land Use Planning Agency.
