Re: BLM Nevada-wide Resource Management Plan (RMP) Modernization Project

On behalf of the Nevada State Land Use Planning Advisory Council (SLUPAC), I am writing this letter, approved by SLUPAC on November 10, 2022, to provide the Council's comments on the Nevada-wide RMP Modernization Project. SLUPAC appreciated the project presentation provided by BLM staff at its August 19<sup>th</sup> meeting in Elko. The presentation was informative and provided SLUPAC with an opportunity to ask questions and share input on the effort to update all 18 RMPs throughout Nevada.

According to the presentation, the average age of a Nevada RMP is 22 years. During this time, new issues have arisen related to land use changes caused by urban development and changing conditions on Nevada's public lands. Additionally, there have been significant policy changes related to recreation, energy production, mineral extraction, land leasing, agriculture, wildfire management, military activities, transportation, and many other land use planning issues. SLUPAC endorses and supports BLM's initiative to update the outdated RMPs, and suggests the update process happen openly and collaboratively. This way, the RMPs can be responsive to these issues and changing conditions for improved land use planning throughout the state.

For example, across the state, Nevada's communities are struggling with achieving housing affordability and availability. There is a statewide deficit of 105,575 affordable housing units and available rentals for households making less than 50% of the state's median income. The lack of affordable and available housing has impacted quality of life, hurt local economic development, and reduced workforce development and attraction efforts in every community. Many communities are surrounded by BLM lands and do not have enough room to grow to meet their housing needs or implement local master plan goals. SLUPAC believes that a collaborative and public process will help ensure housing issues are appropriately captured and addressed in the updated RMPs. This is just one of many examples of land use planning issues that should be part of the RMP update process.

Key to the success of a comprehensive RMP update is to work in close partnership with State Agencies, Tribal Nations, and Local Governments throughout Nevada in a meaningful, collaborative, and transparent manner. With about 67% of Nevada being covered under a BLM RMP, the economies and land use plans of the State, Tribal Nations, and Local Governments will be impacted by the decisions made through this planning effort. These stakeholders can provide the BLM with local knowledge and an on-the-ground understanding of land use planning policies and land management activities across Nevada's public lands. To help give the RMP update process the best chance of success, it will be critical to remain in close communication with these stakeholders and coordinate efforts at each step in the planning process.

SLUPAC acknowledges the challenges, including staffing, resources, and funding, associated with a comprehensive update to Nevada's 18 RMPs. The alternative, to amend RMPs as needed on a project-by-project level, has not been working for Nevada's communities. Projects remain backlogged as they individually make their way through the queue, and the large planning trends and issues stated above do not have a chance to be comprehensively evaluated. Although there are risks in undertaking a statewide update, such as complex local policy issues or land management decisions under one RMP affecting the update of other RMPs or causing the process over all to slow down, SLUPAC believes this risk can be minimized through proactive engagement with local, state and Tribal stakeholders. So that the RMP update can be given the best chance of success and to ensure an effective collaboration with all stakeholders, SLUPAC supports the BLM securing the personnel and resources necessary to complete the initiative, as without them, this large undertaking will be very difficult to accomplish.

In conclusion, SLUPAC supports the goal to update Nevada's public land use plans and hopes that this letter serves to inform and help guide BLM as it works to accomplish the Nevada-wide RMP Modernization Project. RE: State Land Use Planning Agency Update

Since the August 19<sup>th</sup> meeting the Agency has been working on and tracking various activities, SLUPAC projects, Federal public lands and other legislation, and other issues of interest to the Council. The purpose of this memo and agenda item to provide the Council with an update on the agency and provide an opportunity to answer questions or provide additional information.

Bill Draft Requests (BDR) for the 82<sup>nd</sup> Session of the Nevada Legislature: At the August 19<sup>th</sup> SLUPAC meeting, the Council requested an update from the agency on BDR's that have been submitted for the upcoming session of the Nevada Legislature. During the interim between Legislative Session, individual legislators as well as Committees have been working on new legislation that will be considered during the 82<sup>nd</sup> Legislative Session which will begin on February 6, 2023. Although specific language for these bill draft requests is still being developed there have been a total of 469 bills that have been filed for the next legislative session. A complete listing of all of the bill draft requests that have been filed is available at this link. Many of the BDR's that have been filed have been requested by outgoing members of the legislature that will not be in office during the next session. Other BDR's that have been filed may not actually become bills themselves.

Of note for the Council is the work that has been done this interim by the members of the Legislature's Joint Interim Standing Committee on Natural Resources and the Subcommittee on Public Lands. At their August 22<sup>nd</sup> meeting both of these legislative committees submitted their BDR requests that will be considered during the next Legislative session. Many of the BDR recommendations from these committees deal with water, wildlife, environmental, tribal, and other land issues. A complete listing of the Joint Interim Standing Committee on Natural Resources and the Subcommittee on Public Lands is attached to this update. The next major deadline for Legislature is going to be on December 10<sup>th</sup> when incumbent and new legislators will need to submit their BDR's for the upcoming session. Staff has developed a list of BDR's that have been filed that may

- of interest to the Council for review and discussion at this meeting. A copy of the SLUPAC BDR watch list is attached to this update.
- 2) Federal Highway Administration (FHWA) Nevada Federal Lands Connectivity Planning Study: At the July 9, 2021, meeting the Council heard a presentation from the FHWA on the Nevada Federal Lands Connectivity Planning Study. The first goal for this study is to conduct a needs assessment to identify unmet access needs to federal lands and develop a framework to prioritize those needs. The results of this analysis will inform future FLAP calls for projects, and help us better align priorities between FLAP, the Federal Lands Transportation Program (FLTP), and the bigger Fed-Aid program for the state. The second goal of the study is to provide policy and process recommendations for enhanced integration of federal lands access needs into the statewide and Metropolitan Planning Organization (MPO) transportation planning processes. On May 9<sup>th</sup>, the FHWA held a virtual project kick off meeting with stakeholders from around the state. On August 17<sup>th</sup>, the FHWA held a public workshop at Elko city hall and on October 20<sup>th</sup>, the FHWA held a public workshop in at the NDOT Headquarters in Las Vegas to get input for stakeholders on the study. The final workshop for this study will take place on November 10th at 2:00 PM at the River Rock Conference Room at the Renaissance Reno Hotel in Downtown Reno. A virtual option to participate in this final workshop is also available via Microsoft Teams through this link. More information about the Nevada Federal Lands Connectivity Planning Study can be found on the project website.
- October, staff was contacted by the Basin and Range Watch about a proposal developed by the organization to create an Area of Critical Environmental Concern (ACEC) in the Indian Springs Valley north of Indian Springs in Southern Nevada. The proposed 58,000-acre ACEC proposal has been submitted to protect what the USFWS considers to the be the most critical desert tortoise connectivity corridor in Southern Nevada. Basin and Range Watch requested that copy of this ACEC proposal be forward to the Council.   - 4) FHWA Truck Parking Development Handbook: In September the Federal Highways Administration (FHWA) released it Truck Parking Development Handbook. The handbook serves as a resource for planners, engineers, local officials, departments of transportation (DOTs), metropolitan planning organizations (MPOs), economic development organizations, and other entities involved in freight and land use planning. The Handbook also introduces quantitative approaches for estimating truck parking demand and for conducting a benefit-cost analysis of truck parking developments. Practices for siting and designing truck parking facilities are outlined, and the Handbook concludes with strategies for developing truck parking to support driver safety and

security, quality of life in communities with industrial uses, mobility, and economic competitiveness. A copy of the FHWA Truck Parking Development Handbook is available at this link.

- 5) <u>Federal Public Lands Bills</u>: The Agency continues to track the progress of several Nevada specific public lands and natural resource Federal bills. Below is a listing of the bills currently being tracked by the Agency. - 1. Request the drafting of a bill to address water conservation and the enhancement of return flow in southern Nevada, including, without limitation, the use of Colorado River water in septic systems and modifications to the nonfunctional turf program. (**BDR** –)
- 2. Request the drafting of a resolution addressing the management and water conservation efforts of the Colorado River. (**BDR** –)
- 3. Request the drafting of a bill to clarify the processes and authority for the conjunctive management of surface and groundwater basins, including, without limitation, the public notification processes, appeals processes, and the role of science in modifying management practices within such basins. (BDR –)

# Wildlife

- 4. Request the drafting of a bill to authorize Nevada's Department of Wildlife to manage nonpest insects. (**BDR** –)
- 5. Request the drafting of a bill to establish and fund an account with the purpose to identify, construct, and maintain wildlife crossings. (**BDR** –)
- 6. Request the drafting of a bill to adjust the predator fee and to remove the requirement to use 80 percent of the predator fee for the lethal management and control of predatory wildlife. (BDR –)

## Natural Resources Agencies

7. Request the drafting of a bill to establish the Nevada Natural Resources Corps to help attract professionals to Nevada to work for certain state agencies. (**BDR** –)

- 8. Request the drafting of a bill to authorize members of the Nevada State Board on Geographic Names to receive reimbursement for incidental expenses and to be entitled to receive the per diem allowance and travel expenses provided for state officers and employees. (**BDR** –)
- 9. Request the drafting of a bill to require that during the 2023–2024 Interim, the Joint Interim Standing Committee on Natural Resources study state agencies that regulate natural resources. (BDR –)

## Environmental Issues

- 10. Request the drafting of a bill to require local governments to include in their master plan a plan for heat mitigation during their urban planning and local code development efforts. (**BDR** –)
- 11. Request the drafting of a bill to create a working group to review environmental justice issues. (**BDR** –)

## Tribal Issues

12. Request the drafting of a bill to establish qualifications for the tribal liaison position and to adjust state agency employment standards to help tribal members obtain state employment. (BDR –)

#### RECOMMENDATIONS FOR COMMITTEE ACTION

- 13. Draft a position statement in the Committee's final report expressing concerns to proposed water development projects in southern Utah that would negatively impact groundwater and surface water flows in Nevada and supporting aggressive conservation alternatives.
- 14. Draft a position statement in the Committee's final report expressing support for outcome-based grazing practices on federally managed lands.
- 15. Send a letter to the Joint Interim Standing Committee on Legislative Operations and Elections through which the Subcommittee will propose certain statutory changes to the Subcommittee on Public Lands.
- 16. Draft a position statement in the Committee's final report expressing support for funding for the Desert Research Institute, within the Nevada System of Higher Education, and its programs.
- 17. Draft a position statement in the Committee's final report expressing support for the concept of "Smart from the Start" planning to encourage renewable energy development on already disturbed lands and draft a letter to the U.S. Department of the Interior to the same effect.
- 18. Draft a position statement in the Committee's final report expressing support for adequate funding for the Division of Water Resources, State Department of Conservation and Natural Resources, to update its data collection efforts, studies of water basins, and adjudication of water rights.
