The Nevada Chapter of the American Planning Association opens this call for sessions for the 2022 Rural Planning Conference to be held on August 18-19, 2022 in Elko, NV at the Elko Convention and Conference Center.

This year's conference theme is *It Lies Within the Land, Unearthing Our Future and Our Potential.* The conference will focus on how communities are working toward a post-COVID Nevada. Proposals should reflect how planners are addressing issues in Northern, Southern, or rural Nevada, including major planning topics, plans and projects, law, sustainability and resilience, and equity. **The deadline for submissions is Tuesday, June 21, 2022.** Speakers may submit multiple sessions, however, no more than two sessions will be accepted with the same speaker(s).

All who submit session ideas will be contacted following the submission deadline regarding a decision of acceptance. Once a session is chosen, a member of the Conference Committee will contact you to discuss any additional session details. This conference intends to offer as many AICP Certification Maintenance (CM) credits as possible, so session organizers should aim to structure their session(s) to be consistent with the learning objectives of APA's AICP CM program.

SESSION FORMATS

Session formats may include:

- Point/Counterpoint, Panel Discussions, Single Speakers, Moderated Debates, etc.
- The number of presenters in each session is limited to four (4) plus a moderator, if needed, and should last approximately 90 minutes (60 minutes for a Law or Ethics, to fulfill new CM requirements).
- Audio visual equipment (including laptops and LCD projectors) will be provided for each session.
